Our Partnerships

Parents for Children's Mental Health

Kinark values parent/family involvement as a crucial part of mental health services for children and youth. The

selection of evidence-based practices and promising practices incorporates the notion of client/family participation and meaningful input.

Through our broader work around parent engagement, Kinark has established a productive partnership with the provincial organization Parents for Children's Mental Health (PCMH). Our collaboration has led to two important initiatives currently underway.

Family Support Provision

PCMH and Kinark have consistently heard from parents that navigating the children's mental health system and related systems (education, health) can be very challenging in times of crisis. Both organizations have decided to come together to tackle the issue. A proposal was developed to conduct a literature and best practice scan and to hold focus groups to create a "Family Support Provision" model. This model would draw on the expertise of families that had been through the system and would train them to provide peer support to families entering the system. This phase of the proposal was funded by the Ministry of Children and Youth Services. Results were jointly presented to the Minister in February. We are looking forward to piloting the model and further fostering this valuable partnership with parents.

Peer Support Groups

The Parent and Youth Engagement (PYE) Committee decided early on that Kinark should not be in the business of creating and operating parent support groups. In fact, research shows that effective parent groups tend to be run by parents for parents; a sense of ownership is important. Since parent support groups can be a key resource for parents and families dealing with mental health issues with children and youth, Kinark is committed to supporting this type of resource. In the past year, PCMH has revitalized their parent support work and, together, we have started three new support groups in Simcoe, York and Durham.

Student Support Leadership Initiative — Durham

The Student Support Leadership Initiative (SSLI) in Durham Region represents school boards, government ministries, community mental health agencies and community partners committed to providing greater opportunities to youth.

As a member of the SSLI Durham steering committee, Kinark aimed to strengthen the connection between schools and mental health agencies by setting three objectives for this project, which was funded by the Ministry of Health Promotion.

The three objectives for the school 2010–11 school year were:

- professional development
- strengthening and coordinating partnerships
- developing protocol



To accomplish these objectives, three SSLI subcommittees were created with representation from Kinark, Durham District School Board, Durham Catholic District School Board and a variety of community agencies and service providers. Workshops were offered during day sessions for educators, agency personnel, service providers and students, while information booths and resource materials were distributed throughout the day.

Toolkit

A toolkit of mental health information and resources was created and distributed to all schools and partnering agencies and service providers in Durham Region.The focus of the toolkit was to strengthen and coordinate partnerships and professional development around mental health.

Symposium

In April 2011, Kinark participated in organizing a symposium for educators, secondary school students, community agency personnel, service providers, parents and the community at large. Collaborative practice

A protocol was developed to enhance the sharing of confidential information between schools, agencies and medical practitioners through the creation of a framework that is user-friendly and accessible electronically to better meet the mental health needs of students.

Our Innovations

Transforming mental health in Canada: An evidence-based approach

Thanks to the significant change process of Clinical Transformation of the past few years, Kinark has come a long way to increase the use of evidence-based/informed clinical practices (EBPs); ensure the most effective use of available resources; and, most importantly, improve outcomes for children, youth and families. To this end, systematic, measured changes are being made in clinical practice, client service delivery, data collection, education/training, and administrative processes and practices. Notable outcomes include improved cross-agency collaboration. reduced front-door waitlists and improved evaluation processes. To ensure that services are evidenceinformed, an evaluation framework has been developed and applied consistently across EBPs on an approved menu of interventions. This framework, which helps connect evidence to practice, is an important tool in conceptualizing and planning evaluations, articulating program objectives, and linking those objectives to theory, evidence and specific process and outcome factors.

Central Intake

Central Intake is Kinark's front door for children, youth and families who may be struggling with a mental health issue or seeking autism services in the Central East Region.

Families located in our program areas can call Central Intake at I-888-454-6275 and speak directly to a clinician who will guide them through the process. Central Intake provides a combination of services, including referral/intake services, referrals to community resources and general information.

> In Durham Region, a partnership exists which sees Kinark process referrals for several community partners (Chimo Youth and Family Services, Fernie House Child and Youth Services, Frontenac Youth Services, John Howard Society of Durham Region, Lakeridge Health Oshawa Child Youth and Family Program and Ontario Shores Centre for Mental Health Sciences).

This partnership allows Central Intake to offer children, youth and families across Durham Region access to an agency in the community who can best help with the situation they are dealing with.

Central Intake completes an average of 3,200 referrals annually for all agencies.



Our Engagement

Youth

Youth involved with Kinark show their power to effect positive change and make things happen. They do this through a variety of activities in which they show their talent, initiative and leadership. From their design and creation of t-shirts and a slogan proudly promoting a mental health program in Peterborough — "STRIVE, Where Dreams Begin" — through fundraising to support their initiatives, Kinark youth are exercising their many skills, and developing new ones.

The valuable work of Kinark youth in Simcoe, Barrie and Midland has also been flourishing, with an impressive roster of anti-bullying and anti-stigma activities.

This past year also saw the release of the compelling video, *Unmask the Stigma*, produced and submitted by Kinark youth from the Syl Apps Youth Centre as part of an anti-stigma You-Tube video contest hosted by Children's Mental Health

> Ontario and Toronto region member agencies. This initiative aimed to engage Ontario youth aged 13 to 25 in raising awareness and reducing stigma surrounding mental health. The winning video (out of 47 submissions) was created by individuals with identified or suspected mental illness who had experienced the effects of stigma and had something to say about it. The process of producing the video revealed the awe-inspiring creative talents of these youth while humanizing mental illness and reducing fears surrounding it.

> Valuable groundwork has been established for future youth engagement initiatives throughout the agency's program areas, and we are excited to anticipate what lies ahead.



Our Communities

Children's Mental Health Week

Children's Mental Health Week (May 2–8, 2010) kicked off with support from Queen's Park in Toronto as all Members of Provincial Parliament donned Kinark-supplied green ribbons with the message "Children's Mental Health Matters." They wore the green ribbons in the legislature on Monday, May 3, and at functions throughout the week.

The support for Children's Mental Health Week carried into the media with the release of results from Kinark's nation-wide poll which found that one in five Canadians has contemplated or attempted suicide.The online survey was conducted April 12–14, 2010, with a nationally representative sample of 1,000 adults. Articles referencing the survey appeared in several online publications.

Capping the week was recognition earned by youth at the Syl Apps Youth Centre for their award-winning contribution to "Change the View," an anti-stigma You-Tube video contest hosted by Children's Mental Health Ontario (CMHO) and Toronto region member agencies. (See page 8.)

Krista Sepp Memorial Award

On the eve of Children's Mental Health Week, Kinark celebrated the work of Ontario's finest child and youth workers at the 19th Annual Krista Sepp Memorial Award celebration at the Richmond Hill Country Club on April 30.

Ryan McLeod of the George Hull Centre in Toronto was the recipient of the 2010 Horizon Award, which recognizes the work

of a child and youth worker with no more than five years of experience working in the field.

This year's Mentoring Award recipient was Sharon Jones, also of the George Hull Centre in Toronto. The Mentoring Award recognizes the ongoing contributions of direct service staff with more than five years of experience.

Kinark was well represented at the event with four nominees. Mandy Bujold from Simcoe was nominated for the Horizon Award, while Bev Timlin (Peterborough), John Johnson (Simcoe) and Gail Haynes (Durham) were all in the running for the Mentoring Award.

The Krista Sepp Memorial Award was established by Kinark in 1991 to honour the memory of Krista Sepp, who lost her life on February 3, 1989, while performing her duties as a child and youth counsellor. Each year, the Krista Sepp Memorial Awards are held to recognize the high quality work and dedication of child and youth counsellors/workers across Ontario.

Brand strategy

Over the past year, we continued our concerted effort, begun in 2009, to strengthen Kinark's profile and presence through strategic brand building, to develop awareness and understanding of the agency. Through focus groups we examined what Kinark means to stakeholders both inside and outside the agency, to determine how our story — what we promise and deliver — aligns with the



values of the agency and the experience of our clients. This process is a key approach to making Kinark more relevant and tangible to others, and to extend our reach to those in need.


